Helping Those Who Protect and Serve

The heat was brutal; the drought extreme. And the danger of fire was hold-your-breath frightening. But none of that stopped area fire-fighters from battling fires that popped up, including lending much-needed assistance to the devastating fires in Creek County.

"Because they stand between us and those fires, we wanted to lend a helping hand," explains VVEC General Manager Alice Houston. So the co-op donated over 62,000 bottles of water and more than 7,600 bottles of Gatorade to about 40 fire departments in its five-county service territory.

Each day for more than a week and a half, a handful of co-op employees, driving vehicles and trailers loaded down with pallets and cases of the water and sports drink, headed out down paved highways and dirt roads to deliver the supplies.

"Most of them seemed surprised to see us come rolling up," says VVEC Member Services Representative Chub Brewer, grinning. "And everyone we talked to seemed gen-



uinely glad to get the donation."

"These fire-fighters protect our lives, our families, and our property and do it in some of the most extreme conditions," says Houston. "Because the conditions have been so taxing this year, many departments are already exhausting their budgets, so I'm glad we found a way to help them. It's what good neighbors do."

A power cost adjustment (PCA) will be applied to all bills when the actual cost of power purchased exceeds or is less than 55.993 mills per kWh.

In addition, a gross receipts tax of 2% of revenue will be included, plus additional taxes if applicable.

Qualifications to be a Trustee

Electric cooperatives are governed by a board of trustees, who are each members of the cooperative residing in the districts they represent. They are elected to the board by members of their respective districts, at meetings held in the districts. Each trustee serves a three year term, and the terms are staggered so three different trustee terms expire each year.

Qualifications for trustees can be found in the cooperative's bylaws: Article 4, Section 4.

Those qualifications are:

"Each year, there shall be elected trustees to succeed all trustees whose terms of office shall expire at the time of holding such election. All duly elected and qualified trustees shall serve for the term of three (3) years, or until their successors are elected and qualified, subject to the provisions of these bylaws with respect to the removal of trustees.

No person shall be eligible to become or remain a trustee of the cooperative who:

- (a) is not a member and bona fide resident in the area served or to be served by the cooperative; or
- (b) is any way employed by or financially interested in a competing enterprise or a business selling electric energy or supplies to the cooperative, or a business primarily engaged in selling electrical or plumbing appliances, fixtures or supplies to the members of the cooperative; or
 - (c) has been convicted, pled guilty, or pled nolo contendere to a felony; or
- (d) is a close relative of an incumbent trustee or of an employee of the Cooperative, or
- (e) is or was an employee of the cooperative during the preceding three years prior to time of filing or being nominated.

What to do if Your Power Goes Off

1. Check your fuses or circuit breakers. Every service is different. You may have fuses or circuit breakers in your house, on the side of your house, under your meter, or all three places. Check to see if your neighbors have electricity.

2. Call the Co-op at 371-2584, or 1-800-870-5948 if the call is long distance for you. Have your account number, name as it appears on the account, and address handy to give to the dispatcher. If you should get a recording, please don't hang up; leave your information. It will be retrieved and given to the correct department. Every message is answered.

Ownership has its Privileges

Members to Receive \$500,000 in Capital Credit Refunds

There are benefits to being a member/owner of a cooperative. One of those is receiving Capital Credit refunds.

Your board of trustees has recently approved returning \$500,000 in capital credits to VVEC members. The amount will appear as a credit on your October electric bill.

Capital credits are one of the benefits of cooperative ownership and are unique to the cooperative form of business. According to the co-op's auditing firm – Briscoe, Burke & Grigsby – one dollar in five of the co-op's equity has been returned to the members in the form of capital credit retirements.

Clyde Willard, VVEC director of finance, says about 65 percent of that amount, or about \$325,000, will be paid to members who were receiving electricity from the co-op in 2011. The remaining 35 percent, or about \$175,000, is being returned to members who were receiving power in 1981. Refund amounts are based on the electric usage of each member during 1981 and 2011.

As in the past, the credit will be identified as a 'patronage refund' and will be subtracted from the total amount due on your October bill.

Willard says members with multiple accounts will receive one credit on their membership account. That one credit will reflect the total accumulated capital credit refund from all of their accounts.

Willard says this is the 19th consecutive year capital credits have been returned, adding \$13,593,490 has been returned since VVEC was founded.

Former VVEC members will be sent a check for their refund if it is \$5 or more. Lesser amounts will be held in each individual's capital credit account until it reaches the \$5 minimum.

Payment Arrangements Help with Hot Weather Electric Bills



RECIPE

Grandma's Apple Dumplings

2 Granny Smith apples - peeled, cored and quartered

1 (8-oz.) can refrigerated crescent rolls

1/8 tsp. ground cinnamon

1/2 cup butter

3/4 cup white sugar

1 cup orange juice

1 tsp. vanilla extract

Preheat oven to 350 degrees. Wrap each apple piece in one crescent roll. Place seam side down in an 8x8 baking dish and sprinkle with cinnamon.

In medium saucepan, combine butter, sugar, and orange juice; bring to a boil. Remove from heat and stir in vanilla. Pour over rolls.

Bake for 30 minutes, or until pastry is golden and apples are tender. Spoon sauce over rolls when serving.

NOTE: Consider covering dumplings with foil for the first 20 minutes; uncover for the remaining 10 minutes so they can get a pretty golden brown.
