VVEC releases applications for 2018 Adopt-A-School and Rural Fire Department grants

As an electric cooperative, VVEC's primary objective is to provide safe, reliable and affordable electricity to our members. However, we are also a concerned partner in the development of the local community. One of the ways VVEC demonstrates our concern for the community is by offering grants to schools and rural fire departments in our service territory.

Each year teachers, school administrators and fire department personnel are invited to submit an application for funds through VVEC's Adopt-A-School and Rural Fire Department grant programs. Applicants are asked to explain how they will use the funds to improve the classroom experience for students or to help protect residents' lives and property from fire damage.

"The grant has helped out classrooms quite a bit," VVEC Member Services Representative Chub Brewer says. "It allows schools to fund something that's not in their budget to enhance the students' learning experience."

Likewise, fire departments purchase tools and equipment they might not otherwise be able to afford. In turn, these purchases help improve the safety of the members of the community.

VVEC shares the "cooperative difference" at the Tulsa Farm Show

All electric utilities offer the same product—electricity—but where it comes from makes a difference. Unlike for-profit utilities, electric cooperatives are owned by their members, and their end goal is serving the membership—not generating a profit. This is what is known as the "cooperative difference" and it's the message VVEC shared during the 24th Annual Tulsa Farm Show.

The event, held each December at Tulsa's River Spirit Expo attracts more than 30,000 attendees from Oklahoma and surrounding states. The most recent show, Dec. 7-9, 2017, featured more than 370 agriculture-related businesses and organizations. Also in attendance were five of Oklahoma's electric cooperatives.

Has your status changed?

If you recently tied the knot, got divorced or were widowed, please call us so we can update your account. We need up-to-date, accurate information for your capital credit account, but also to make it easy for you to conduct business with us. Federal legislation enacted after Sept. 11, 2001, prevents us from discussing an account with anyone not listed on it. If you have been wid-owed, your account will be placed in your name, but we need you to update your application. If your parents or another family member were VVEC members and have passed away, we need to be aware of that because we cannot have an account in the name of a deceased person. We will be glad to work with you on updating your account. Please call our consumer service representatives at 918-371-2584.

Eliminate fluctuating electric bills with the AMP Plan

If your electric bill fluctuates from month to month, you might want to try the Average Monthly Payment Plan. The AMP Plan is available to VVEC members who meet all the following criteria:

Have been a VVEC member for at least 12 months;
Have not been late in paying the electric bill more than twice during the previous 12 months;The electric bill is currently paid in full.

Your average monthly payment is figured by taking your current month's usage plus the preceding 11 months' usage and dividing them by 12. This total is then figured into the applicable rate along with any taxes and plus or minus onetwelfth of your balance forward.

The average is recalculated every month in the same manner.

RECIPE

Romance Cake

Yields a 9-by-13-inch cake

For the shortbread:

- 1 cup all-purpose flour
- 1/2 cup margarine
- 2 tablespoons sugar

For the filling:

- 1 1/4 cups brown sugar
- 2 eggs, beaten
- 1 cup chopped walnuts
- · 2 tablespoons flour
- 1/2 teaspoon baking powder
- 1/2 cup flaked coconut
- 1 teaspoon vanilla extract

For the icing:

- 4 tablespoons margarine
- 2 cups powdered sugar
- 1 teaspoon vanilla extract
- 3 tablespoons cream or milk

Preheat the oven to 350°F. For the shortbread, mix ingredients in a medium bowl, like pie dough, and press firmly into a 9-by-13-inch baking dish. Bake for 20 minutes.

For the filing, combine ingredients in a large bowl and pour over cooked shortbread. Bake for 20 minutes. Cool completely.

Combine the icing ingredients in a medium bowl and beat until smooth. Spread over the cooled cake.
