VVEC returns \$1,000,000 in capital credits

Eligible co-op members to receive credit on October electric bills


here are benefits to being a consumer-owner of a cooperative. One of those is receiving capital credit refunds. Your board of trustees has recently approved returning \$1,000,000 in capital credits to VVEC members. The amount will appear as a credit on your October electric bill.

Capital credits are one of the benefits of cooperative ownership and are unique to the cooperative form of business. According to the co-op's auditing firm, Briscoe, Burke & Grigsby, one dollar in five of the co-op's equity has been returned to members in the form of capital credit retirements.

This year's retirement will be approximately \$1,000,000 and will be paid to members receiving electricity from the co-op in 1983 and 2020. Refund amounts will be based on the dollar amount billed to each member in 1983 and 2020 for electric usage.

As in the past, the credit will be identified as a "patronage refund" and will be subtracted from the total amount due on your October bill.

Members with multiple accounts will receive one credit on their membership account. That one credit will reflect the total accumulated capital credit refund from all of their

Incumbent trustees seek re-election

his fall, members in Districts 1-6 will cast ballots for VVEC board trustees at their district meetings. Last year's district meetings were canceled due to the COVID-19 pandemic, and the board voted to allow the trustees in Districts 1, 3 and 5, who would have been up for re-election, to continue in their roles for an additional year. As a result, those elected in Districts 1, 3 and 5 will serve a two-year term. Regular elections will be held for Districts 2, 4 and 6 and elected representatives will serve a standard, three-year term.



District 1 - Jim Brackett

Jim Brackett has been a VVEC member since 1973 and has been on the board as a trustee since 2010.

He and his wife, Pam, live in the South Coffeyville area where they have a cow-calf operation. Brackett worked for VVEC and retired after a 33-year career. They have four children and numerous grandkids.

"I appreciate the opportunity to serve as a board trustee and represent the members of District 1," he says.



District 3 - Vernon Lewis

Vernon Lewis has been a member of VVEC since 1968 and was elected to the board of trustees in 1984. He also represents VVEC on the Oklahoma Association of Electric Cooperatives board of directors.

Lewis completed certification as a cooperative director from the National Rural Electric Cooperative Association in 1998 after completing the required number of continuing education classes offered to board trustees. He has also earned his Board Leadership certification and the Gold Certificate.

Coconut Key Lime Cream Pie Yields 1 pie

Ingredients

- 11-ounce package vanilla wafers
- 1/3 cup butter, melted
- 2 cups heavy whipping cream
- 1/4 cup confectioners' sugar
- 1/2 cup Key lime juice, divided
- 8 ounces cream cheese, softened
- 14-ounce can sweetened condensed milk
- 1 teaspoon coconut extract
- 1 cup shredded coconut
- 1/4 cup toasted shredded coconut
- Lime zest and maraschino cherries

In a blender, pulse vanilla wafers into crumbs. Add melted butter and pulse until combined. Press crumbs into bottom and up sides of greased 9 1/2-inch deep-dish pie plate. Refrigerate 30 minutes. In large bowl, beat whipping cream until it thickens. Add confectioners' sugar and 1 tablespoon lime juice; beat until stiff peaks form. Remove 1 cup; set aside. In separate large bowl, beat cream cheese until smooth. Add sweetened condensed milk, coconut extract, remaining lime juice and shredded coconut; beat until combined. Stir in 1 cup of reserved whipped cream. Pour into crust. Top with whipped cream. Refrigerate 4 hours. Just before serving, garnish with toasted coconut, lime zest and cherries. *Recipe and photo courtesy of Culinary.net*
