Damage From The Storm

Spearheading Summer Storm Damage

As the scorching summer sun beats down, severe storms can often disrupt the tranquil serenity of the season. The repercussions of summer storms can be felt most intensely in the form of power outages, leaving communities in distress. In the early morning hours of June 18th, Father's Day, severe storms with high winds rolled through Northeastern Oklahoma. Outage notifications began coming in at 12:17 am. However, amidst the chaos and darkness, Verdigris Valley Electric Cooperative emerged as a beacon of hope, tirelessly working to restore power and bring relief to affected areas. Through our dedicated efforts, VVEC has proven our commitment to customer service and community welfare. One of the defining characteristics of VVEC is our swift response to power outages caused by the summer storms. The storm hit hardest in our service areas of Rogers and Tulsa counties resulting in 78 broken poles and other infrastructure damage leaving us with over 20,000 meters without power. Equipped with a robust emergency response plan, the cooperative sprang into action, mobilizing their skilled personnel and resources to address the situation promptly. By assessing damage and outage numbers by service area, VVEC was able to dispatch crews and equipment strategically, ensuring a rapid and efficient restoration process. Safety remains a paramount concern for VVEC during power outage recovery efforts. Their highly trained linemen adhere to rigorous safety protocols to protect themselves and the community while working in hazardous conditions. By meticulously assessing the situation and identifying potential risks, VVEC ensures that our restoration efforts proceed smoothly without compromising the well-being



of our workers or residents. During challenging times, effective communication becomes crucial for providing updates and support to affected communities. VVEC utilizes social media and our website to keep customers informed about outage status, estimated restoration times, and safety reminders. In the wake of summer storms, the tireless efforts and dedication of Verdigris Valley Electric Cooperative shined through as we worked diligently to restore power and offer solace to our members. Most all power had been restored on Tuesday, June 20th with the last service being restored on Wednesday, June 21st . With a strong focus on safety, efficiency and collaboration, VVEC has proven to be an invaluable resource during times of crisis. As we navigate the uncertainties of severe weather, we can take pride in knowing that VVEC remains steadfast in our mission to provide reliable power and unwavering support to the communities we serve.

VVEC is thankful and appreciative of our members for their patience during this restoration process.

Chuck Wagon Cookies

- 1/2 c. shortening
- 1/2 c. brown sugar
- -1/2 c. white sugar
- -1/2 c. peanut butter
- 1 c. peeled, grated
- apple
- -1 1/2 c. flour

- 1 tsp. soda
- 1/2 tsp. salt
- 1/2 tsp. cinnamon
- 1 egg
- 1/2 tsp. vanilla

Cream shortening, sugars, peanut butter and egg. Sift dry ingredients; add to creamy mixture. Add apples and vanilla. Shape into balls, size of walnut, flatten on a cookie sheet with fork or thread spool. Bake at 350 degrees for 10 minutes.

Think Safety As Your Student Moves Into The Dorm

It's the time of year when college campuses are preparing for students moving all of their worldly possessions into their home away from home – the dorm! While this is an exciting time for the students, it can be a nerve-racking time for parents. Safe Electricity reminds parents and students to keep electrical safety in mind.

* Don't overload outlets, extension cords, or power strips.

* Use power strips with over current protectors. This will shut off the power if there is too much power being drawn.

* Only purchase and use electrical products tested for safety. Some common approved safety labels include UL, CSA, and MET.

* Keep all electrical appliances and cords safely away from bedding, curtains, papers, and other flammable material.

* Make sure outlets around sinks are equipped with ground fault circuit interrupters (GFCIs) before use. If they are not, contact the resident assistant, campus housing staff, or landlord.
* Unplug small appliances when not in use and all electronics when away for extended periods.

* Always use microwave-safe containers. Glass, ceramic containers, and plastics labeled "microwavesafe" should always be used. Metal and aluminum foil can damage the microwave or start a fire. If the microwave is damaged in any way, do not use it.



* Never disable a smoke detector; and never ignore a fire alarm or assume it is a drill. Every time a fire alarm sounds, residents should calmly and quickly follow practiced procedures and immediately exit the building. * When planning to move into a shared space like a dorm or university housing, Bob Wilczynski, assistant director of housing at the University of Illinois has a few insights. "Communicate with your roommates before shopping for items for the room. Often times when there is no communication room's end up with multiple refrigerators and microwaves, which can lead to a circuit overload in a small space."

Wilczynski adds that you should check with your university's housing department on their specific housing laws. Many colleges across the U.S. ban cooking appliances from oncampus housing, including hot plates, coffee makers, and microwaves. Many of these institutions provide a designated area for the use of these products.

• First, check your fuses or circuit breakers. Every service is different. You may have fuses or circuit breakers in your house, on the side of your house, under your meter, or all three places. Check to see if your neighbors have electricity.

• Then, call the co-op at 371-2584, or 1-800-870-5948. Have your account number, name as it appears on the account, and address handy to give to the dispatcher. If you should get a recording, leave your information; every message will be answered

• Download the SmartHub app at www.smarthubapp.com to report outages from your smartphone.
